WHAT IS TAX?

'In this world nothing is certain except death and taxes'

Every area of your day-to-day life is impacted by tax, from the food you eat for breakfast to the road you travel to college or work on. Hospitals, schools, transportation routes, fire services and police forces are all paid for by taxation.

HM Revenue and Customs has collected over £780 billion in taxes in a single year.

With every budget the tax rules change, and individuals and organisations need tax professionals to provide expert advice navigating complex tax legislation.

WHY CHOOSE A CAREER IN TAX?

A career in tax has an enormous amount to offer, including variety, intellectual stimulation and plenty of responsibility.

Once qualified, your career path can take you in many different directions. How does it work?

The ATT qualification consists of three core elements:

- Two compulsory online examinations
 Certificate Paper 1: Personal Taxation
 Certificate Paper 2: Business Taxation
- Three compulsory Computer Based Examinations (CBEs) Law
 Professional Responsibilities & Ethics
 Principles of Accounting
- Your choice of any one of the following four online examinations Certificate Paper 3: Business Compliance Certificate Paper 4: Corporate Taxation Certificate Paper 5: Inheritance Tax, Trusts & Estates
 - Certificate Paper 6: Value Added Tax

Your achievement is recognised at each stage of learning. A pass in an examination paper will entitle you to a Certificate of Competency in that subject, with no requirement for practical UK tax experience.

Students with the ATT qualification, and who have two years' practical tax experience, can apply for ATT membership. Members are entitled to use the designatory letters 'ATT' after their name and the descriptive title 'Taxation Technician'.

TRAINING CONTRACT

To apply to be an ATT member, as well as passing the required exams, you will need to have completed two years' practical tax experience. This experience can be completed through a training contract, which is offered by some firms as a way of studying while working.

You will be interviewed, just like any other job and, if successful, will work as a paid employee, getting the experience you need at the same time as studying for the ATT qualification and taking your professional exams. Most firms will even cover the costs of joining the Association as a student, training and the exam fees too.

Member Spotlight

Gurdeep Singh Dhanjal, Tax Manager (Sports & Entertainment), HW Fisher:

A career in tax wasn't always my plan, but I found an intriguing opportunity within the sports and entertainment sector and haven't looked back since. The qualification covers the depth and breadth of tax, and working in the profession is certainly more rewarding once you have a high level of technical understanding. of the challenge and put the time into my studies to complete the qualification.
