

WHAT IS TAX?

Every area of your day-to-day life is impacted by tax, from the food you eat for breakfast to the road you travel to college or work on. Hospitals, schools, transportation routes, fire services and police forces are all paid for by taxation. In the 2021-22 tax year, HMRC collected £715.5 billion in taxes.

With every budget, the tax rules change and individuals and organisations need tax professionals to provide expert advice navigating complex tax legislation.

To become a tax professional requires no previous qualifications, and whether you are studying or already working, the Association of Taxation Technicians (ATT) can put you on the route to become a Taxation Technician, studying at a time and place that suits you.

Once qualified, your career path can take you in many different directions. You may decide to specialise in a particular branch of taxation e.g. you may become a personal tax specialist advising individuals, or you may prefer to advise companies on corporate tax and VAT. You can work for a professional firm, with a business, for the government, for a charity or on your own. There are even opportunities to work abroad.

To be eligible to register as a student you must be at least 16 years old with a reasonable standard of English and Mathematics.

There are study options to suit everyone, from classroom learning and online distance learning to self-study. Whatever your preference, you will find a method and provider that works for you.

For example: Based on the Association of Accounting Technicians qualification, you might be eligible to apply for the following exemption(s):

Examination: Principles of Accounting (Computer Based Examination).
Criteria AAT Level 4 exam qualified.

Exemption fees:

- £98 per CBE
- £185 per certificate paper

How does it work?

The ATT qualification consists of three core elements:

◆ Two compulsory tax papers

Certificate Paper 1: Personal Taxation Certificate Paper 2: Business Taxation

◆ Three compulsory Computer Based Examinations (CBEs)

Law

Professional Responsibilities & Ethics Principles of Accounting

Your choice of any one of the following four tax papers

Certificate Paper 3: Business Compliance

Certificate Paper 4: Corporate Taxation

Certificate Paper 5: Inheritance Tax, Trusts & Estates

Certificate Paper 6: Value Added Tax

Your achievement is recognised at each stage of learning. A pass in an examination paper will entitle you to a Certificate of Competency in that subject, with no requirement for practical UK tax experience.

Call yourself a Taxation Technician: joining ATT

Students who pass the two compulsory tax papers, three compulsory CBEs and any one of the other tax Certificate papers and who have two years' practical tax experience can apply for ATT membership. Members are entitled to use the designatory letters 'ATT' after their name and the descriptive title 'Taxation Technician'.

Tax fact

How does it work?

The route consists of five different stages:

◆ Core knowledge 1
 Sit two ATT papers of your choice, with complete flexibility as to which papers are taken

◆ Core knowledge 2Sit either a third ATT paper or the CTA Awareness paper

Principles of Accounting, Law and Professional Responsibilities
 Ethics examinations

Three examinations assessed as Computer Based Examinations (CBEs)

At this point, you will be eligible for ATT membership provided you have also achieved two years' practical experience in taxation.

◆ Advanced Technical KnowledgeSit two CTA Advanced Technical papers

◆ Application and Professional Skills (APS)
 Select whichever case study question from the APS paper you prefer

When all the elements of the Tax Pathway have been completed, together with three years' relevant recent professional work experience, you will be eligible for membership of the Chartered Institute of Taxation (CIOT).

ATT APPRENTICESHIP

Delivering the End-Point Assessment in partnership with NCFE.

- Work alongside experienced staff and gain on-the-job experience
- ◆ Earn a salary and get paid holiday leave
- ◆ Be allocated time for study

How does it work?

ATT works in partnership with NCFE in the delivery of the Level 4 Professional Taxation Technician Apprenticeship for End-Point Assessments (EPAs).

The EPA for Taxation Technician contains two methods of assessment:

- ◆ Portfolio of Evidence including Reflective Statement demonstrating competence in the knowledge, skills and behaviours identified in the standard
- ◆ Role simulation completing a series of short tasks about a fictitious organisation

"I found out about a career in tax when I was coming to the end of my A-Levels. I decided on the apprenticeship because it would be a quicker route to where I want to be. It only took me two and a half years to complete the ATT qualification after leaving school.

How do they work?

The ATT offers four independent online Foundation Qualifications in partnership with Tolley Exam Training. These can be studied in any order, and you can study for any number.

Personal Taxation Business Taxation VAT Compliance
Transfer Pricing

Each qualification is split into four modules of learning and testing.

Once you have passed the four modules you then have to complete the Final Certificate Examination.


