



Guidance on how to register for the new service

Welcome to the new Community Forums service.




New Forum registration screens

Go to 'Sign In'




Then click on the 'Register' tab Provide the details requested.




Click '**Update**' which will return you to the profile page. Select '**Home**' on the top menu bar to access both the Customer Forum and Knowledge Base.

Known Issue

When using the Agent forum, you may experience the following issue (see screenshot below).



Whilst we work on a permanent fix for this, as a temporary work around please remove “-origin” from the URL e.g.

Removing “-origin” from the URL will fix the issue.
